Supplier Registration Application Forms are available from the Finance Department of the Municipality at 34 Church Street, VRYBURG, 8601.

Quotations will be evaluated according to the DR RUTH S MOMPATI DISTRICT MUNICIPALITY's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act (Act 5 of 2005) and the Preferential Procurement Regulations, 2011, Preferential Procurement Point System Applicable is 80/20 as well as the Broad Base Black Economic Empowerment Act (Act 53 of 2003).
